C.<u>Finance report</u> -Jesse- We have a cash balance of approximately \$95,000.00 with all bills paid. Some upcoming costs will be \$9,700.00 for the new carts and \$7,383.00 for the conversion of the outdoor freezer to a refrigerator which is expected to begin March 13th. D.<u>Grounds report</u> - Jim- The mower reels are in Little Chute for sharpening, the dry fertilizer is here and the liquid is ready to be delivered when requested. The new work cart is ready for delivery as well. The new trash bins have been ordered along with some new sand containers for tee repair sand.

E.<u>Manager report</u> - Vicki - The credit card service, I Merchant, has fully refunded the \$1,840.00 they owed. The new golf carts will be here in May with a balance due of \$9,700.00. We've decided to increase our fleet to 39 carts to accommodate a full course with a few spare carts if needed. Our oldest carts are 2008. We will continue the rotation next season. The installation of the new hot water heater and water conditioner is finished. The conversion of the outdoor freezer to a refrigerator will begin March 13th. The new doors on the clubhouse have been installed. The porch roof is leaking due to ice backup and rain. The construction company has been contacted and will repair as soon as weather permits. The pro shop has been restocked with new items and we have new lights and paint in the bar room for a fresh new look. We're excited for the 2023 season! There are 3 stock transfers; Roger Lotto to Robert D. Lotto, Tim Chrisman to Jeremy & Ashley Seiler, and Carol & Pete Tomasi to Carol Tomasi (re-issue of lost stock). Motion to accept Manager's report by Harry, 2nd by Jesse. Motion carried.

F.<u>Old Business</u> - More discussion about the stand alone glass washer for behind the bar. We need to find one that will fit into the space available and costs involved. Tom will contact Dave Ashbeck and other handyman businesses in the area for an estimate on remodeling the bathrooms on tee #6.

G.<u>New Business</u> - Debbie Paul is willing to take "ownership" of the landscaping duties around the clubhouse, flag pole and the bathroom building on tee #6. She said it needs some TLC which we all agree. A motion was made by Kevin to hire Debbie as our Landscape Artist and allow initial funds for repairs be \$2,500.00, 2nd by Larry. Motion carried.
