That part of the claim did not qualify due to incorrect or defective material or installation. We are working to solve the problem with AC Construction Co. We received an estimate from Oneida Roof & Chimney in the amount of \$12,300.00 for the roof repair. After discussion, Ken made a motion to accept the bid, 2nd by Kevin. Motion carried. Vicki has a full staff ready to greet the public. She is putting together plans for a membership appreciation night to be held on June 12th from 5 to 7 p.m. There will be food and drink specials and members of the board will be working and on site to listen to any concerns or comments. Come in and enjoy this social event! There is 1 stock transfer; Carol Tomasi to Robert or Mary VanGrunsven. Motion to accept Manager's report by Tom, 2nd by Kevin. Motion carried.
